FINDINGS:

The Court expressed their displeasure that the Clerk of the Course and the Secretary did not attend the Court of Enquiry.

The Court found that:

1. Whyte, Bornman and Moore be removed from the results in the Regional 50cc class.
2. Competitor Justin Buist be removed from the results in the MX2 class.
3. Competitor Sussman be removed from the MX Lites class.

The club WRH is fined R2000.00 (two thousand rand) which is suspended for 6 (six) months as of 14th April 2011 for allowing an underage competitor to ride in a class and a non-regional licence rider to score in the regional class.

The Clerk of the Course's licence is suspended for 6 (six) months from 14th April to 14 October for posting the results without checking them. This sentence however is suspended for 6 (six) months from 14th April 2011

All parties are reminded of their right to appeal
