## **MSA COURT OF ENQUIRY 1114:**

Held to investigate aspects arising from the Regional/Club X-Country Motorcycle and Quad event hosted by South Coast Motorsport Club on 16th March 2013 at Ifafa Indaba, and the subsequent actions of Mr. Harry Timmerman, which it is alleged constituted abuse of officials and brought the sport into disrepute (see GCR's 154, 211 & 172).

The Court President introduced the court members and asked those present to introduce themselves.

The Court President asked if anyone had any objections to the composition of the court. No objections were raised.

After hearing all the evidence and considering all the submissions provided, the court finds Mr Harry Timmerman guilty of abusing officials and severely reprimands him in this regard. In addition, Mr Timmerman's competition licence is withdrawn for a period of six months. This withdrawal of licence is however suspended for six months with effect from 01 June 2013, and will only come into force should Mr Timmermann again be found guilty of abusing officials during this period (01 June to 30 November 2013).

All parties are reminded of their rights of appeal to the MSA National Court of Appeal.

Findings were read out at 19h45 on 30th May 2013, and subsequently issued in writing via email.
