## MSA COURT OF ENQUIRY 1137

### THE ENQUIRY ARISES FROM VARIOUS ALLEGATIONS LODGED BY THE WESTERN PROVINCE MOTOR CLUB (WPMC) AGAINST THE BEHAVIOUR OF COMPETITOR, MR TIAAN BRANDT

HEARING HELD AT THE MSA OFFICE IN CAPE TOWN ON THURSDAY, 2<sup>ND</sup> OCTOBER 2014 AT 18H00

The Court President introduced himself and the court members. There were no objections to the composition of the court.

1. Evidence was given on three (3) separate incidents over three (3) different race meetings this year, where members of WPMC felt Mr. Brandt's' behavior was overly aggressive. Two (2) of the incidents involved spectators.
2. The versions of the incidents by both parties were very similar with minor differences.

The Court finds as follows:

1. There is insufficient evidence to prove any wrong doing on the part of Mr. Brandt and it seems that although he has been involved in three (3) altercations this year, none were of any serious nature and all were none violent.
2. Mr. Brandt is however cautioned that in the future he should rather walk away from any volatile situations and report these matters to either the officials on the day or WPMC staff so they may handle the situation.
3. WPMC is cautioned for bringing the matter to the attention of the WC MSA Regional Committee without being able to provide substantial and concrete evidence for their case.

All parties are reminded of their rights to appeal.
