MSA COURT OF ENQUIRY 1193

HEARING HELD AT THE MSA OFFICE IN CAPE TOWN AT 19:30 ON 10th MAY 2017

INTRODUCTION:

The Court President introduced himself and the other court members. There were no objections to the composition of the court.

THE HEARING

- Motorsport South Africa has convened a Court of Enquiry in terms of GCR 211 to investigate, inter alia whether Mr Dayne Angel has breached the Karting SSR's Section B 15 or General Competition Rule GCR 121 (i), 127 C, 136 or any other GCR in relation to allegedly competing at a WPMC Karting event without the correct licence on the 01st April 2017.
- 2. The court determined the following:
 - a. Competitor Angel has previously competed in more than one category of motorsport in any one year and held the correct licences for all facets he competed in.
 - b. Competitor Angel was allegedly allowed to compete with his Formula Supercar Circuit Car licence in karting in Johannesburg.
 - c. The Race Secretary on the day was a stand in for the regular Race Secretary.
 - d. Competitor Angel did show the Race Secretary a licence on his phone who according to her statement only saw the word "Clubman's" on the licence and presumed it was for Clubman's karting. She accepted the licence as correct.
 - e. The WPMC Karting Section has already been fined an amount of R1000 by Motorsport South Africa for allowing this competitor to compete without the correct licence.

f. Competitors sign entry forms acknowledging that they are familiar with the rules and regulations of Motorsport and the Class they compete in.

FINDINGS:

- 3. Findings:
 - a. Competitor Angel is fined the amount of R500 for competing without the correct licence.
 - b. Competitor Angel is ordered to pay court costs of R1000.
 - c. Competitor Angel's licence is withdrawn for one (1) year and this sentence is suspended for a period of three (3) years. Should he be found guilty of a similar offence in that period the one year withdrawal will come into effect.
 - d. The court notes with concern that once again there were administrative issues at a WPMC Karting event. This not long after the club was cautioned about administrative short comings in the findings of COE 1190. Although the club has already been fined an amount of R1000 the court feels the fine should be R5000 as per Appendix R 2 g) but will suspend the R4000 for a period of one (1) year. Should any further administrative issues arise the additional R4000 fine will come into effect.

All parties are reminded of their rights in terms of GCR 212 B.
