INTRODUCTION

The court members and attendees were all introduced and no objections were lodged against the composition of the court.

THE HEARING

On the 11th December 2017, Motorsport South Africa ("MSA") enrolled Court of Enquiry 1208 ("the Enquiry") to investigate whether Mr. Fanie Naude had breached GRC 172 iv. The Court considered evidence by Mr. Fanie Naude and Mr. Riaan van Wyk.

This is the written judgment of Court of Enquiry 1208. The enquiry took place on 11th December 2017 between approximately 17h00 and 17h30.

FINDINGS

Having heard all the parties present the court finds as follows:

1. Mr. Naude and Mr. van Wyk are both reprimanded and reminded to follow the correct procedures when lodging a complaint.
2. The licence of competitor Eduan Naude is suspended for a period of one (1) year. This suspension is on condition that Mr. Fanie Naude is not found guilty of breaching GCR 172 during this period of suspension.
3. Mr. Naude is fined an amount of R5000.00. An amount of R3000.00 of this fine is however suspended for a period of three (3) years. This suspended amount is subject to Mr Naude not been found guilty of breaching GCR 172. Should this happen the suspended portion of the fine will come into immediate effect.
4. Mr. Naude is levied is further ordered to pay court costs in the amount of R1000.00

All parties are advised of their rights in terms of GCR 212 B.
