INTRODUCTION:

The Court President introduced himself and the other court members. There were no objections to the composition of the court.

1. THE HEARING

Motorsport South Africa has convened a Court of Enquiry in terms of GCRs 154 and 211 to investigate the running of the final heat for the Supermod class at the Zone 7 Dirt Karting event held on 01 June 2019, and whether or not this race should be scored towards the Club Championship.

2. EVIDENCE LED

The court listened to evidence from all the parties present and it was clear that the correct procedures were not followed on the day in order to declare the results of the final heat of the Supermod class as invalid and therefore not to be scored towards the Club Championship. Furthermore, not all the competitors were present when the Assistant Clerk of the Course informed competitors of the Clerk of the Course's decision in this regard.

3. COURT FINDINGS

- a) The court finds that, due to incorrect procedures or lack of procedures followed on the day, the results for the final heat of the Supermod class must be re-instated and it will therefore count towards the Zone 7 Dirt Karting Club Championship.
- b) Officials had a difficult job on the day and most of them are still new to Dirt Karting. They are still learning how to work together as a team but they are extremely enthusiastic and the court believes that with the right guidance and training they will become a great team.

All parties are reminded of their rights in terms of GCR 212 B.
