#### INTRODUCTION

The court members and attendees were introduced, and no objections were raised against the composition of the court.

The hearing was called to investigate a complaint received from Mrs Malaika Motlekar, the parent of competitor Ghazi Motlekar as to alleged irregularities that took place at the National Rotax Karting Championship held on 10 August 2019 at Idube Kart Circuit.

A meeting had been called between MSA, the Karting Commission and the complainant, her husband and advocate to discuss the various issues raised. The Court was informed that as an outcome of this meeting Mrs Motlekar had formally withdrawn her complaint.

The Commission President, however, was of the opinion that the CoE should continue and after discussion the Court agreed to pursue this course of action.

#### THE HEARING

Mr Ed Murray, promoter of the series, was afforded the opportunity to address the court on various aspects of the complaints received.

The Court questioned Mr Shuttle on the allegations relative to the standard of marshalling and marshalling procedures.

#### **FINDINGS**

The court was satisfied that the meeting between the various parties had resolved all the issues and that no further action was necessary. The Karting Commission and MSA are applauded for arranging this meeting and is of the opinion that communication between officials and competitors and parents of competitors, as the case may be, is essential to resolving the issues currently being experienced in Karting.
