INTRODUCTION

The court members and attendees were introduced, and no objections were raised against the composition of the court.

THE HEARING

The hearing was called to investigate a complaint received from Mrs Malaika Motlekar, the parent of competitor Ghazi Motlekar as to alleged irregularities that took place at the Rok National held at Idube on 17 August 2019.

A meeting had been called between MSA, the Karting Commission and the complainant, her husband and advocate to discuss the various issues raised. The Court was informed that as an outcome of this meeting Mrs Motlekar had formally withdrawn her complaint.

Mr Faizal Motlekar informed the Court that he and his family were of the opinion that the matter had been amicably resolved at the meeting mentioned above and confirmed that the complaint was therefore withdrawn.

FINDINGS

The court was satisfied that the meeting between the various parties had resolved all the issues and that no further action was necessary.

The Karting Commission and MSA are applauded for arranging this meeting and is of the opinion that communication between officials and competitors and parents of competitors, as the case may be, is essential to resolving the issues currently being experienced in Karting.
