The Court President introduced himself and the court members. There were no objections to the composition of the court.

After having heard and examined the evidence presented by all parties, the court finds as follows:

1. The court members find in favour of Mr Johan Hamman, and rule that competitor JP Hamman's finishing position to be reinstated.
2. After viewing various video evidence supplied by both competitors, it is difficult to verify exactly which specific incident was ruled on during the protest hearing by the Stewards of the day.
3. It is clear from all video footage watched, that there was bumping by both competitors during the heat and in one incident competitor number 4 was knocked off the circuit.
4. Both competitors, Hamman #23 and Busi #62, are to be placed under observation for the next three (3) events.
5. The appeal fee, less 10% for administrative costs, is to be returned to the appellants.

All parties are advised of their rights to appeal to the MSA National Court of Appeal.
