The president introduced himself and the Court Members, there were no objections to the composition of the Court.

Findings:

It is clear to the court that there was physical abuse perpetrated by Tyler Croy on Troy Dolinschek. Mr Theo Croy did present video evidence of an on track incident that he felt had led to the frustration experienced by Tyler, thus causing the outburst. Unfortunately there is no excuse for this behavior and there are clear procedures in place should a competitor feel aggrieved by on track incidents.

Ruling:

The court believes that although the Stewards do not hold the authority to withdraw a competitor's licence, the intended consequence of the competitor's actions was noted by the Stewards. Therefore in line with the Stewards intention this court suspends Tyler Croy's competition licence up to and including 31 December 2015, without the proviso of any suspensive effect. (For clarification this ruling is intended to remove the competitor from any form of motorsport for the balance of the 2015 season).

All parties are reminded of their rights in terms of **GCR 212B**.
