## MSA COURT OF APPEAL 404

**APPEAL LODGED BY MR FERNANDO PATRIZI AGAINST FINDINGS OF THE STEWARDS AT THE REGIONAL KARTING EVENT HELD AT VKC ON THE 14<sup>th</sup> SEPTEMBER 2013. HEARING HELD IN THE MSA BOARDROOM ON THE 2<sup>nd</sup> OCTOBER 2013 AT 17h00.**

The president introduced himself and the other court members. There were no objections to the composition of the court.

After having heard and examined the evidence presented by all parties, the court finds as follows:

The penalty imposed by the MSA Stewards is hereby set aside. The penalty is set aside due to the fact that there were five missing karts from the field, due to previous accidents and false starts, which created an uneven grid, which was then closed up by the competitors in the left hand lane, causing them to be ahead of their normal qualifying position. The Court finds that these competitors were merely complying to the Karting Regulations Section E Article 18 (xii).

In view of the success of the appeal, the appeal fee is returned.

The Court directs that the official race results be reinstated in accordance with these findings.

All parties are reminded of their rights of appeal.
