The Hearing

The Court was informed that witnesses Mrs. Tanya Dias and Mrs. Jeanne White had tendered their apologies and informed the Court Scribe that they would not be attending the hearing. The Court was presented with affidavits from the witnesses. The MSA Steward Jacobus van Niekerk had also tendered his apologies and was available by phone if needed.

The Court afforded the opportunity to Mr. Di Bella of addressing the Court on the alleged Contravention of GCR 172 vi

The Court then heard statements from Mr. Kevin de Wit, Mr. Neil Robertson, and Ms. Vivienne Keytel.

The Court considered the evidence of the aforementioned witnesses. In considering the elements and evidence, the Court takes cognisance of the provisions of GCR 211 and GCR 220.

Findings:

The Court after having heard the evidence and the submissions of Mr. Di Bella, the Court cannot accept the given reasons for expectation in close proximity to fellow competitors.

The Court therefore finds that Mr. Di Bella is in contravention of GCR 172 vi and in terms of GCR 's115 & 116

Mr. Di Bella's son, Turidu Di Bella is hereby given a three race ban. This includes National, Regional and Club events.

The Court finds that the actions of Mr. Di Bella is viewed in a very dim light, and he is hereby requested to reacquaint himself with the GCR handbook.
