- b. Forfeit the right to take part in or be connected in any capacity whatsoever with any competition held on the territory of the ASN, (MSA in this instance)
 - c. The afore-mentioned individuals are directed to immediately hand back all the licences to MSA within a period of 7 days.
3. In relation to competitor Shawn Collins that made certain representations, which set out the circumstances of his participation the explanation was accepted by the court, hence the following sentence is imposed:
 - a. R2000-00 fine.
 - b. Suspension and withdrawal of licence, which sentence is suspended for a period of 2 years, on condition that the fine in terms of GCR 177(i) and GCR 180 (i) – (iv), is paid within a period of 48 hours and the competitor concerned, does not participate at any non-sanctioned events.

All parties are reminded of their right to appeal.
