COURT OF ENQUIRY HELD INTO THE ALLEGED CONDUCT OF THE ORGANIZER, MR HENNIE GREYVENSTEIN TOWARDS A MSA DRAG RACING COMMISSION MEMBER, MR MOHAMED DAWOOD, ON THE 7TH AUGUST 2011, AT THE NITRO RACEWAY DRAG RACING EVENT. THE HEARING HELD AT 15:00 ON MONDAY 29TH AUGUST 2011 AT MOTORSPORT SA, NO. 9 MONZA CLOSE, KYALAMI PARK, MIDRAND, 1686

The court president introduced the court members and there were no objections to the composition of the court.

In terms of GCR 220, the hearing may proceed to judgment in default of appearance by any party or witness.

FINDINGS:

After having heard all the evidence and submissions by all parties, the court finds that both parties were amiss in the incident that occurred at the gate. Mr Mohamed Dawood didn't display his MSA Access card in the beginning and the heavy approach by the gate representative (Nitro Raceway gateway) Mr Anton Alberts, by his own admission, resulted in a verbal altercation and abuse between Mr Dawood, Mr Hennie Greyvenstein and Mr Anton Alberts in an open forum and in the presence of spectators etc.

1. The court finds that Mr Mohamed Dawood, as a MSA Commission member, should know the MSA procedures more clearly and that he brought the sport into disrepute. Mr Mohamed Dawood is therefore receives a fine of R5000-00 **SUSPENDED** for 1 year.

2. The court finds that the conduct of Mr Hennie Greyvenstein, owner of Nitro Raceway, an affiliated MSA Club, in relation towards Mr Mohamed Dawood improper and receives a fine of R5000-00 **SUSPENDED** for 1 year.
3. The court believes that, Ms Rochholz as a previous employee of MSA, should be totally ofét with all MSA card procedures. Based on the fact that Ms Rochholz did not inform the organisers or the gate keepers of the various MSA accreditation card procedures, the court imposed a fine of R2000-00 **SUSPENDED** for 1 year on Ms Rocholz. The information regarding the procedures on all MSA accreditations must be circulated by Ms Rochholz to Mr Hennie Greyvenstein, Mrs Isabel Greyvenstein (Nitro Raceway) and Nitro Raceway staff.

All parties are reminded of their right to appeal.
