#### **MSA GENERAL CIRCULAR 2 OF 2025**

Affected parties are hereby advised that the following change to version 1 of the 2025 MSA General Competition Rules (GCRs), PART IX PROTESTS, is made with immediate effect:

#### PROTEST FEES (VAT not applicable)

## The following protest fees will apply in all instances,

a) International events	R20 000
b) National events	R10 000
c) Regional events	R5 000
d) Club/Social events	R2 000

- 1. The standard protest fee as outlined above, will be applicable for all protests lodged by a competitor/entrant at an event.
- 2. Should a protest lodged by a competitor/entrant be deemed unsuccessful, the fee for a subsequent protest lodged by the same competitor will be double the fee of their previous unsuccessful protest.
- 3. The escalation of protest fees for a competitor/entrant will remain binding and in effect for a cycle of three (3) years, commencing 1 January 2025.
- 4. In the event of an unsuccessful protest, MSA will issue an invoice to the competitor/entrant for any escalated protest fees, as referenced in point 2 above and illustrated in the below example, within seven (7) business days following the outcome of the protest. The invoice shall be paid within 48 hours of it being emailed (Saturdays, Sundays and Public Holidays excluded) and any delay in making payment will entail suspension of licence (in the case of competitors and officials), or suspension of rights to stage events (in the case of clubs).
