Where the combined unit, does not traverse the entire route, a penalty of 30 minutes plus time for the advantage gained will be applied at the discretion of the COC.*

*Pit crew refers to all persons who support a rider e.g., the riders mechanical crew, his family, friends and sponsor and/or Entrant, this list is not complete.*

### **INSURANCE:**

*The organisers pay a levy on behalf of the competitors and officials, towards a Public Liability Policy which is held through MSA.*
