MSA WESTERN CAPE REGIONAL CLASSIC CAR CHAMPIONSHIP CIRCULAR 01 OF 2026

Affected parties are hereby advised that as prescribed in the 2026 MSA Western Cape Regional Classic Car Sporting Regulations and the 2026 MSA National Technical Regulations for Pre-80 and Pre-90, the following is stated for clarification purposes:

1. In order to compete and to score in the 2026 MSA Western Cape Regional Classic Car Championship, the competitor **MUST** be a paid-up member of Classic Car Sub-Section as per MSA Western Cape Regional Classic Car Sporting Regulations Article 4.1.b.
2. In addition, each racing car must have a valid Historical Technical Passport (herein referred to as an HTP) as per MSA Western Cape Regional Classic Car Sporting Regulations Article 4.1.c, without which the competitor competing in that car will **NOT** be eligible to score points in the Championship.

It therefore stands to reason that each racing car (with a valid HTP) when entering the circuit for any official session needs to comply with the 2026 MSA National Technical Regulations for Pre-80 and Pre-90's (as per MSA Western Cape Regional Classic Car Sporting Regulations Article 6.1) in all respects (incl. but not limited to tyres, bodywork, engines, etc).

3. Any dispensation granted in 2025 was only applicable for the calendar year of 2025, which expired on 31 December 2025, and therefore is no longer in effect.
4. MSA Historic Circular 1 of 2025 was applicable for the calendar year of 2025, which expired on 31 December 2025, and therefore is no longer in effect.
