**The riding of pit bikes, motorbikes and bicycles in the pits, other than by competitors is not permitted.**

**The purpose of the Event is to test the reliability of the motorcycles and the skill of the participating competitor as a combined unit. Where the combined unit, does not traverse the entire route, a penalty of 30 minutes plus time for the advantage gained will be applied at the discretion of the COC.**

**Pit crew refers to all persons who support a rider e.g., the riders mechanical crew, his family, friends and sponsor and/or Entrant, this list is not complete.**

##### **INSURANCE:**

**The organisers pay a levy on behalf of the competitors and officials, towards a Public Liability Policy which is held through MSA.**
